Rules: USEF rules will be followed to biting, saddlery and use of tie-downs. Riders must wear hard hats and footwear with heels. 2007 USEF tests will be used. Stallions must be attended at all times. Horses not to be shown must have a negative Coggins presented at the office. A donation to GCC would be appreciated for admittance of horses not to be shown.

Directions: Hidden Wind is located near the intersection of 111st St. S. and Garnett. **From Tulsa or from the north or east** take the 91st St. S. exit off of Hwy. 169. Turn left (east) on 91st S. to Garnett. Turn right (south) on Garnett to 111th St. S. Turn left onto 111th St. S. and make the 1st left onto Butternut and follow the road through the subdivision to the farm, go through the brick gateway, and then to the right of the house to go back to the barns. **From OKC or from the south or west** take the Creek Turnpike to the Mingo Street exit turn right (south) on Mingo. Go to 111th St. S. and turn left, go one mile to Garnett, continue straight to Butternut, the next left after Garnett; follow Butternut through the subdivision to the farm, go through the brick gateway, and then to the right of the house to go back to the barns.
