**Entry fees:** \$25.00 for a "Do-Over" test (2007 GCC volunteers get one free test). Limit one "Do-Over" test per horse/rider combination. Additional tests are \$15. The first score on "Do-Over" Test will count toward GCC year end awards. The second try will get a scored test but will not count toward awards. If riding two tests you can choose to ride your "Do-Over" test either first or second. Because "Do-Over" tests take more time rides are limited. First come first served. If the day fills before the closing date we'll post notification via the GCC website. For questions and clarifications contact Jolie'.

Please limit your entry to two rides (one Do-Over & one regular or two regular).

**Rules:** USEF rules will be followed to biting, saddlery and use of tie-downs. Riders must wear hard hats and footwear with heels. 2007 USEF tests will be used. Stallions must be attended at all times. Horses not to be shown must have a negative Coggins presented at the office. A donation to GCC would be appreciated for admittance of horses not to be shown.
