**Guidelines For Protective Headgear:**The US Equestrian Federation passed rule DR120.5 "Protective Headgear for Dressage," which will go into effect as of March 1, 2011.

**Effective March 1, 2011, for dressage: Anyone mounted on a horse must wear a riding helmet, with the harness secured, meeting or exceeding the ASTM SEI standards for equestrian use, except those riders age 18 and over while on horses that are competing only in FEI levels and tests at the Prix St. Georges level and above (including FEI Young Rider Tests, the USEF Developing Prix St. Georges Test and the USEF Brentina Cup Test). Failure to do so after one reminder will incur elimination from the competition.**
