Rules: USEF rules will be followed to biting, saddlery and use of tie-downs. Riders must wear hard hats and footwear with heels. 2007 USEF tests will be used. Boots and bandages permitted. Stallions must be attended at all times. Horses not to be shown must have a negative Coggins presented at the office. A donation to RCC would be appreciated for admittance of horses not to be shown.

Concessions: Will be provided by Majic Stable juniors.

Directions: If heading south to Norman on I-35 take exit 112 toward Tecumseh Rd. Turn left at N Interstate Drive. Take the 1st right onto W Tecumseh Rd. About 2-1/2 miles turn left onto 60th Ave. About 1 mile turn right onto W Rock Creek Rd. Destination on left almost 1 mile. If heading North to Norman on I-35 take exit 110 for Robinson St. Head west on W Robinson St. Go about 2.7 miles and make a slight right onto 60th Ave. Go about 1 mile and turn left onto W Rock Creek Rd. Destination on left almost 1 mile.

If cancellations are necessary, a full refund will be made if the show manager is notified before the closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10.00 office fee. All no-show entries will be billed to the rider. Arena is 5 feet short of large arena.
