Rain date: Extreme wetness or rain could cause cancellation. Riders will be notified as soon as possible if cancellation is necessary. Full refunds will be issued if show(s) is/are cancelled.

Format: You may choose to compete in the combined test with dressage and stadium jumping all in one day or you may choose to compete in the horse trial which will hold the cross-country phase on Sunday. On Sunday, June 27th, a second show will be held which offers a combined test with dressage and cross-country. Extra dressage tests will be held each day.

Awards: Ribbons will be awarded 1st to 6th place (Cash prizes and gift vouchers for 1st and 2nd places in horse trial and combined test, amounts to be determined by June 23rd)

Closing date: Saturday, June 19th

Ride Times available: Wednesday, June 23rd, after 7:00 pm

Rules: USEF rules will be followed to biting, saddlery & use of tie-downs. Riders must wear hard hats & footwear with heels. 2007 USEF tests will be used for dressage only; Intro A and B are the 2007 USDF tests; 2010 USEF tests for combined test and horse trial. Stallions must be attended at all times.

Directions: From Tulsa I-44 west. Exit at #211 (Kellyville/Drumright). Take a left toward route 66, then turn right onto route 66 (toward Kellyville) Go 2 miles. Turn left at signs for Schlumberger and Kellyville rodeo arena onto W. 141st. St. South. Look for a black welded fence on the right in about ¼ of a mile, entrance soon after. **From Oklahoma City take I-44 east** Exit at # 211 (Kellyville / Drumright). Turn right, then right again on route 66 then follow directions above (Go 2 miles...).

Jr. and Sr. (Am or open) will ride separately and be placed separately in combined test and horse trial. Show management reserves the right to change ride times when deemed necessary to facilitate timely completion of the show. Entries must be received by closing date at 5:00 p.m. Late entries may be refused or charged a late fee of \$20 at the discretion of the show management. If cancellations are necessary, a full refund will be made if the show manager is notified before the closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10.00 office fee. All no-show entries will be billed to the rider
