## **Proposed Changes to Oklahoma Dressage Association Bylaws**

### **Article VIII Officers**

#### **Section 1: Number and Election**

All Officers shall be Senior ODS members in good standing *and be an elected member of the Board of Directors. Exception is a CPA who volunteers to be the ODS Treasurer.* The Secretary shall be a resident of the State of Oklahoma. The Officers shall be a President, a Vice President, a Secretary and a Treasurer, plus any other officers as may be designated by the Board. Officers shall be elected by the Board of Directors at the first meeting of the year of the Board of Directors. *With the exception of the Treasurer,* Officers shall hold their positions for one (1) year or until successors are elected. *The Treasurer will hold their position for 15 months to allow a three (3) month overlap with new Treasurer.*

### **Article VIII Officers**

#### **Section 2: Duties and Authority,**

B. In the absence of the President, or in the event of the President's inability or refusal to act, the Vice President shall perform the duties and have the authority of the President. The Vice President shall perform such other duties as the President and / or the Board of Directors may assign. *The Vice President is the President elect for the following year. The Board reserves the right to re-elect the President and Vice-President for a second term if agreed to by the President and Vice-President.*

### **Article X Chapters**

#### **Section 3. Governance**

The general membership of each ODS Chapter shall elect a Board of Directors composed of not less than three (3) ODS Senior members in good standing, one of whom shall be elected as the Chapter Presiding Officer. The Chapter may elect or appoint such additional Officers, as it deems necessary to properly conduct the affairs of the Chapter. *Officers must all be elected Chapter Board members.*

# Proposed Policy and Procedures Amendments- Summer meeting

The previous Board proposed these Policies and Procedures Amendments. However in the change-over between Officers these Amendments were never posted as required by the Policies and Procedures.

## IV. Board of Directors

### A. Definition

3. ODS Board members must represent ODS above their respective Chapters and cannot serve on Chapter Boards.

## IX. Chapters

### B. Governance

1. The general membership of each ODS Chapter shall elect a Board of Directors composed of not less than three (3) ODS Senior members in good standing, one of whom shall be elected as the Chapter Presiding Officer. Chapter Board members cannot be a member of the ODS Board or another Chapter Board. The Chapter may elect or appoint such additional Officers as it deems necessary to properly conduct the affairs of the Chapter. Chapters shall have the latitude to decide for themselves whether these officers are elected directly by their membership or are appointed by their Chapter Board.

#### ODS Academy Awards Sponsored by Cheryl West and West Equestrian

**Mission Statement: To find the ultimate lesson student who is capable of riding multiple horses, and to find the ultimate school horse who willingly carries and teaches all riders. ODS Academy Horse Award Requirements:**

- A minimum of 5 scores with 3 different riders
- Must be ridden in USDF test at Intro level or above
- The rider cannot be the owner of the horse
- Horse can be un-papered, but must have an ODS registration number
- Horse must be part of an active riding or lesson program
- Horse must be 5 years old or older
- Recipient is determined by median score
- Award will be presented to the program that owns the horse
- Scores can cross all levels

#### **ODS Academy Rider Award Requirements:**

- A minimum of 5 scores on 3 different horses
- Must have ridden a test at USDF Intro level or above
- Rider must be a member of ODS
- Scores can cross all levels above Intro
- Recipient is determined by median score
- Rider cannot be the owner of the horse
- Horse must have an ODS registration number

**A line will be added to the schooling show entry forms to indicate that the horse is an Academy horse so that the horse and rider are eligible for the award.**
